



Call for Artists!

The Oakhurst Arts & Music Festival • October 9, 2010

Entry postmark deadline: August 20, 2010

The Decatur Arts Alliance invites you to apply for booth space in the juried outdoor Artists Market area of the Oakhurst Arts & Music Festival. The festival will be held in historic Harmony Park in the city of Decatur, Georgia, just miles from downtown Atlanta. The artists market will be open from 10 am until 7 pm on Saturday, October 9, 2010. The festival features continuous entertainment on the music stage adjacent to the Artists Market, a Children's Arts Festival and a Community Pavilion.

Fees:

A nonrefundable processing fee of \$20 is required. The booth fee is \$65 for a 10'x10' booth space. Two checks, for \$20 and \$65 must accompany the application. Booth fee checks from artists not accepted will be returned. No rain date and no refund of booth fees from accepted artists. Checks post-dated or returned unpaid by the bank will result in immediate disqualification.

Jury Procedure:

Two ways to submit artwork for consideration:

- CD with four jpeg images: three of artwork one of booth display
- **CD must be marked with the artists' name. Include a self-addressed, stamped envelope, business size or larger, with sufficient postage for return of your CD.**
- Send only the number of images requested. We will not view more than the amount requested.
- Only original artwork will be considered. No manufactured or buy/sell.
- If accepted, exhibitors must only show and sell work of the same type and style as demonstrated in the slides submitted with the entry application.
- **All applications must be postmarked by August 20, 2010. No late entries will be accepted**
- **Submissions will be juried and artists will be notified of the results by September 2, 2010**

Sales Tax:

Each exhibitor is responsible for collecting and remitting the 7% Georgia sales tax. Forms are included in the information package provided at artist check-in.

Judging and Prizes:

Prizes for First, Second and Third Place will be awarded. Judging for prizes will begin at noon. Winners will receive automatic entry and free booth space in the 2011 OAMF.
